He also told the boar been contacted by neighbors living along the road regarding the status of the area where boats are being taken of the lake. Nothing will be discussed by the Board until the road project has been completed.

Weed Supervisor Discussion: Steve Reilly reported to the Board that Crow Wing County does not have a contact regarding weed supervision. Steve was given completed weed evaluation forms which were completed by the T years ago. These forms were completed up to 2007. Steve will do some further checking into this topic and repeated to the Board at the August Special meeting.
