A motion was made by Josh Thompson and seconded by James Walth to propose \$470,000 for the 2019 Levy to be presented at the Township annual meeting to be held at the Deerwood Town Hall on March 13, 2018 at 6:30pm. This levy is a 11% increase in comparison to the 2018 Levy. \$50,000 of the \$80,000 going into the General Fund will be allocated for future Capital Improvements to avoid the need for future borrowing and interest payments. The Board was in agreement that the Township needs to save money for future improvements instead of borrowing the money. All voted in favor of the motion. Break out of the levy is as follows:
