A motion was made by Josh Thompson and seconded by James Walth to designate the Town Hall, Deerwood Post Office and the Deerwood True Value as the official Public Notice Posting Location for the Township. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by James Walth to designate Deerwood Bank as the official bank depository for the Township. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by James Walth to designate the CI Courier as the official newspaper for public notice publications. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by James Walth to set the date and time for the Monthly Board of Supervisors meeting for the second Monday of the month. If that date falls on a national holiday the meeting will be the Thursday following that Monday. All voted in favor of the motion. Motion passed unanimously. The Board meeting schedule is posted on the Township website.
