North Hamlet Road: The Board read an email from Tom Sura regarding his concerns with snow removal on North Hamlet Road. Steve has been in contact with Tom.

Placid Drive Signage: Steve reported to the Board the signs have been installed.

Chip Seal Projects for 2024: Steve told the Board he has turned in the request for the 2024 road chip seal project to Crow Wing County. He has not received any unit costs yet. He is expecting the cost to be around \$90,000.

Joint Powers Agreement between Deerwood Township and the City of Deerwood Regarding Deerwood Lane and Forest Lane Discussion: Carol Pundt is working with Lee Russell to formalize a new contract to include a 60 day contract cancellation notification.
