David Gray called the meeting to order at 8:09am with the Pledge of Allegiance. A motion was made by Josh Thompson and seconded by David Gray to approve the agenda.

A motion was made by Josh Thompson and seconded by Scott Brix to set the date and time for the 2<sup>nd</sup> half of the Township maintained road inspection for May 17, 2025, to meet at the Deerwood Town Hall at 8am. All voted in favor of the motion. Motion passed unanimously.

The list of roads to be inspected was reviewed by the Board. The road inspection began at 8:39am. The Board decided to inspect the following roads today: Anne Lake Road, Beaver Creek Road, Casey Lake Road, Cedar Height Circle, Cedar Lake Drive, Cedar Shores Drive, Cedar Springs Lane, Country Lane, Lakewood Drive, Nelson Drive, Nelson Fork Road, Orland Mine Road, Rice Lake Road, Rocky Ridge Road, Town Line Lake Road, Vision Drive, White Pine Drive, Orland Mine Road.

The Supervisors returned to the Town Hall at 12:10pm.

The Board decided to pay special attention to 4 roads (Townline Road, Cedar Shores, Nelson Drive and Beaver Creek).

A motion was made by Josh Thompson and seconded by David Gray to have Steve Reilly get estimates to replace 2 culverts and riprap 100 feet on both sides of the culvert on both sides of the road on Townline Road to be discussed at the May Board meeting. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by David Gray to have Steve Reilly fill in the hole on Town Line Road. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by David Gray to have Steve Reilly get estimates for ditching, class 5 and tailings on the swampy section/turn-a-round in an area on Cedar Shores and Cedar Heights Circle. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by David Gray to have Steve Reilly get an estimate regarding a patching project on Nelson Drive. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by David Gray to have Steve Reilly get an estimate for tailings on the turn-a-round and low spot by the creek on Beaver Creek Road. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by David Gray for Steve Reilly to get estimates for dust control for Deer Trail, Peterson Lake Road, Scandia Road, Mallar Road, Black Bear Road and portions of Orland Mine Road. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Scott Brix and seconded by Josh Thompson to have signs replaced on Casey Lake Road back through to Cedar Shores Road. All voted in favor of the motion. Motion passed unanimously.

A motion was made by Josh Thompson and seconded by David Gray to have crack filling done on Placid Road, Nelson Fork Road, Miller Circle and Lakewood Road limited to a cost of approximately \$10,000.

Plans for future maintenance and improvements were recorded and will be discussed at the May Board meeting.

A motion was made by Josh Thompson and seconded by Scott Brix to adjourn the meeting at 12:51pm. All voted in favor of the motion. Motion passed unanimously.
